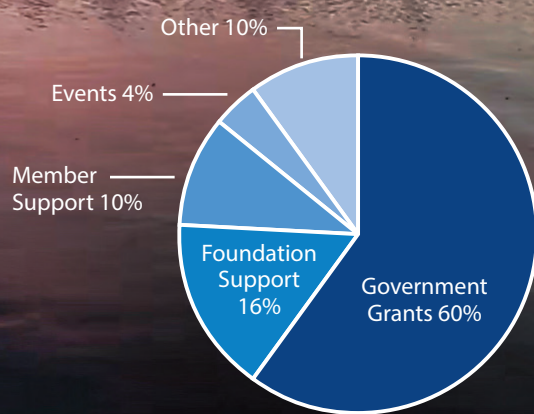

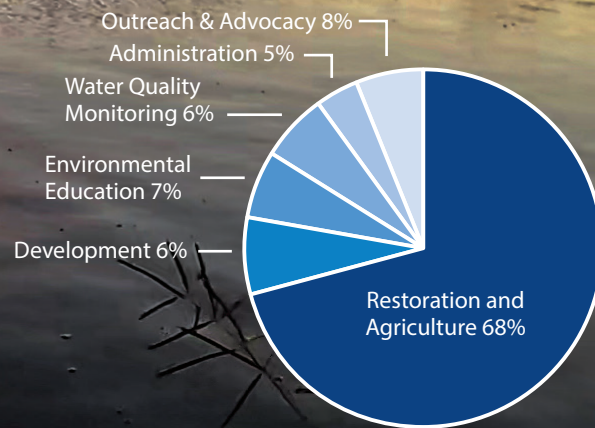

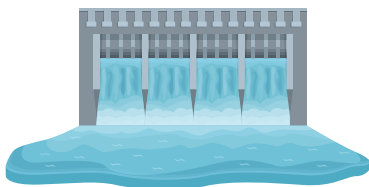


Inspired members to generate **426 LETTERS OF OPPOSITION** to the AquaCon salmon factory to protect endangered sturgeon.

# EDUCATION



Investigated local environmental issues with

Connected students with their local waterways through **40 LAND-AND WATER-BASED FIELD EXPERIENCES**, taking many students canoeing for the first time!

Facilitated collaborative curriculum writing and professional development with **30** teachers in three counties.

Monitored and recorded **882 DATA POINTS** related to standard, scientific water quality parameters at **63 SITES** throughout the region.



Welcomed **200 NEW VOLUNTEERS** to take our total to more than 1,000 hand-raisers ready to help with anything from trees to trash.

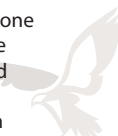
